SUPREME COURT ADVISORY COMMITTEE

ORDERED that:

1. The Court's Order establishing the Supreme Court Advisory Committee issued in Misc. Docket No. 09-9004 (January 15, 2009) is vacated, and this Order is substituted.

The Supreme Court Advisory Committee, first created in 1940 and periodically reconstituted since then, assists the Supreme Court in the continuing study, review, and development of rules of administration and procedure for Texas courts, taking into consideration the rules of other courts in the United States and proposals for changes from whatever source received. The Committee drafts rules as directed by the Court; solicits, summarizes, and reports to the Court the views of the bar and the public on court rules and procedures; and makes recommendations for change. Votes taken by the Committee are solely for informational purposes. The Committee's discussions and recommendations are advisory and not binding on the Court.

Committee meetings are held after public notice and are open to the public. A record is made of all Committee proceedings. Committee expenses are paid from funds appropriated by the Legislature or provided by the State Bar of Texas.

Members of the Committee are appointed by the Supreme Court, which from time to time determines their number, qualifications, and terms of service. A Chair appointed by the Court to serve at its pleasure calls meetings with the approval of the Court, prepares an agenda in advance of each meeting, and presides over the meetings. Proposals, drafts, and other materials to be discussed are provided at or before meetings.
